What about other products?

Here are some great questions to ask manufacturers and suppliers to better understand the quality and consistency of their products.

Sourcing

- 1. In what country is the product grown?
- 2. Is it certified as hemp? By whom?
- 3. Is it grown naturally using organic processes?
- 4. Can you track production of the product from seed to delivery?
- 5. Is there a consistent supply? Is it possible I'll run out?

Quality

- 1. How many milligrams of active cannabinoids (CBD, THC, THC-A, etc.) does the product contain? What is the total volume (milliliters) of the product?
 - a. Active cannabinoids are typically described in terms of milligrams per milliliter (mg/ml).
- 2. Is the product third party tested for the following:
 - a. Identity
 - b. Potency (Cannabinoid Profile)
 - c. Heavy Metals:
 - i. Inorganic Arsenic
 - ii. Cadmium
 - iii. Lead
 - iv. Methylmercury

- d. Residual Solvents
- e. Aflatoxins
- f. Microbial Contaminants:
 - i. Aerobic Plate Count
 - ii. Yeast and Molds
 - iii. Coliforms
 - iv. Salmonella spp.
 - v. Escherichia coli

- 3. Is it produced in an FDA registered lab?
 - a. Are they following the FDA's CGMP standards?
 - b. Do they adhere to the American Herbal Products Association (AHPA) guidelines?

Cost and Customer Service

- 1. What is the cost per milligram? Is there financial assistance?
- 2. Is there a refund policy?
- 3. Is customer service readily available?
- 4. Who will help me with questions regarding use of the product?
